# Budget Bill HB 1600 (Chapter 725)

Mr. Murray presented information on the FY2026 Virginia Budget which includes language providing funds for "a one-time bonus payment, equal to 1.5 percent of their base salary on July 1, 2025" for full-time detention center and juvenile delinquency prevention staff.

Shawn Utt made a motion to approve the utilization of these funds for a one-time bonus payment to all full-time AJC staff equal to 1.5% of their base salary. Rhonda Lester seconded the motion.
